A set up for another Holocaust Help us before it's too late

The Holocaust has parched itself into the consciousness of Jews, and after more than forty years its impact is felt even more ardently. The mood was set to kill the Jew in Europe and Spain. Barely a month goes by that doesn't mark the emergence of a book or movie or study on the impact of this austere period in our Before history. them had been murdered. That is the end of the story, but where does it end? Believe it or not, it still hasn't ended. They are trying it again with another group of people- the Nuwaubians!

As many of you know, the founder of the Nuwaubians is Rev. Dr. Malachi Z. York. As a Hebrew, Rev. Dr. Malachi Z. York was Bar mitz vahed in 1958 A.D. by the Great Rabbi: Wentworth Arthur Matthews of Harlem at age 13. Rabbi Matthews was the leader of the Moorish Zionist Temple of the Moorish Jews. This is where the word Moor comes from, from the Moorish Science Temple. Through the school of Judaism, Reverend Malachi Z York translated the Torah and the Psalms from the Ancient Aramic Hebrew into English.

Long before any Moorish Science Temple came into existence, Rabbi Matthews called his temple, The Moorish Zionist Temple of the Moorish Jews. This lets you know that he was affiliated with the Moors. Also, if you look at the organization called Ethiopian Hebrew Congregation in which Rabbi Wentworth Matthews was a practitioner, they have on the first page of a book entitled, How the Hebrews Became Jews, put out by the Ethiopian Hebrew Congregation, "To my grandmother, Hannah Melchezedik, granddaughter of a Moraccan Hebrew King who was married to a Scot. Peter Malcolm, and to their child, my mother, Ada Malcolm." This dedication points out the Moroccan involvement to make the point that Rabbi Matthews was also involved with the original Moorish movement. This goes back to the word Moor, where the word Moroccan came from. The word Moor is derived from the Latin word "Mauri" meaning a "deep dark-brown." Which comprises the western portion of modern Algeria and the northeastern portion of modern Morocco.

During the Middle Ages, Jews lived in Eastern Europe, occasionally in cities but more frequently in **small communities** (*shtetlach*; singular, *shtetl*) where they had vastly developed community institutions. The Eastern European *shtetl* exists only in memory and in artifacts. It was the foundation of the majority of American Jews whose grandparents arrived in the great waves of immigration around the turn of the century. Although there are still a few Jews living in Eastern Europe, the wealthy and essential world of Eastern Europe Jewry perished in the dreadful Holocaust.

The Holocaust came about mainly as an effect of an environment of anti-Semitism that had saturated European

many Jews left the country, others chose to remain and converted to do so. Some of these converts secretly practiced Judaism and came to be known critically as Marranos (Moreno; Moors). According to the American Heritage Dictionary, Marranos means a Spanish or Portuguese Jew who was forcibly converted to Christianity in the late Middle Ages but who continued to practice Judaism in secret. In Spanish, it means swine, Marrano (from the Jewish prohibition against eating pork). It was done to be insulting, however, this word also stems from the word "Moreno," which means "Black" as in supreme balancement, not the color, as in the group of people known as Moors.

Throughout the centuries, anti-Semites manufactured a number of calumnies (a false statement maliciously made to injure another's reputation; the utterance of maliciously false statements; slander) to provoke resentment against the Jews on the part of the public. These accusations motivated mobs of hysterical fanatics and encouraged them to vicious physical attacks on Jews. Such attacks, known in Russia as pogroms, were often instigated by government officials and assisted by church leaders. According to the American Heritage Dictionary a pogrom is an organized, often officially encouraged massacre or persecution of a minority group, especially one conducted against Jews.

Centuries of anti-Jewish teachings fashioned fertile ground for the seed of Nazi hatred to flourish. The people had been trained to loathe Jews and to see them as something less than human. Thus they could justify the elimination of the Jews, not as murder, but as the removal of a cancerous element in society or the destruction of parasites or peets.

Millions of people from many ethnic backgrounds were killed in Nazi extermination camps, but Adolf Hitler single-mindedly pursued with fierce passion his goal of annihilating the Jewish people. He conceived of it as "the final solution of the Jewish problem." The horrid destruction of some six million Jews (including one and a half million children) is well documented and need not be elaborated here. The names of Aushwitz, Bergen-Belsen, Dachau, and many more camps remain glorified in the memory of the generation that witnessed the mayhem and those who have learned of it since. The riddance of over six million individual human beings solely because they were Jews is its own kind of terror.

Putnam County Patterns York Case after MOVIE!

"Charges So Shocking, The Truth Didn't Matter"

Starting January 27th 2003, Newton County will be hosting one of the most publicized and highly profiled cases in Georgia's history. The case of Rev. Malachi York and Kathy Johnson and the 208 alleged child molestation charges launched against them by a disgruntled son, several vindictive women and a power hungry sheriff. Both of the defendants have maintained their innocence and the evidence supports their innocence, even to the point where all 5 of the children taken by the Department of Family and Children Services (DFACS) to be investigated for molestation and abuse were returned to their families with no signs that they had been sexually molested in any way by Rev. York or any of the other defendants. The most disturbing aspect of the prosecution's whole case is how the steps taken by the District Attorney Fred Bright and the other prosecutors are IDENTICAL to that of a case that took place in 1983 A.D. in Manhattan Beach, California called the "McMartin Trials". This was a trial about a family that owned and operated a preschool in Manhattan Beach and was alleged to have sexually molested over 200 children from ages 2 to 14 years of age. They ended up with exactly 208 counts against them; but after 7 years of trial and 16 million dollars paid by the state they all were vindicated of all charges in the end. In 1995 A.D. there was an HBO movie entitled "Indictment" (ISBN 0-78310-

853-2) that was a re-enactment of this actual trial. Citizens of Newton County need to be made aware that this Copy-Cat Prosecution has similarities that are so close and so identical to the McMartin Trials that it is terrifying knowing that human lives are at stake. Southern Poverty Law Center contradicts mission of tolerance




to sway potential jurors.

Every name added to the Wall will serve as a call to action for other Americans of good will to follow your example and join in this great campaign for tolerance and justice." With all this recognition, Morris Dees blatantly overlooked Mr. Jackson's involvement with the Al Mahdi Shrine and labeled the group a hate group. Mr. Jackson has been a public servant for over twenty years and is currently employed as a certified peace officer in the state of Georgia. Mr. Jackson is just one of hundreds of men in this organization that exemplify such honorable character worth national recognition.

One of the biggest arguments to justify the SPLC's stand against the Nuwaubians and any organization associated with them, is that Rev. Dr. Malachi Z. York teaches his
